Pre-qualification Criteria for Electrical Work (Internal and External) for New Block of FORE School of Management, New Delhi

1. The contractor should have average annual financial turnover not less than Rs. 5 Crore during last 5 years ending 31/03/2011.
2. The contractor should have satisfactorily completed at least 5 jobs of electrification work (internal and external) in the last 3 years.
3. The contractor shall have a valid registration certificate for sales tax, service tax, work contract tax, E.S.I. and P.F. etc.

4. The Contractor should have Electrical License for Delhi state.
