Work includes Design, Manufacture, Supply, Installation, testing and commissioning of without machine room lifts at the above campus. The work is to be completed in a time bound schedule of **6** months from the date of award of work and shall be carried out strictly as per technical specification/ drawings, best workmanship and quality.

- 2. Eligible and approved reputed Contractors to be pre-qualified who meet the following basic qualifications:
- a) Average annual financial Turnover not less than **5** Crore Rupees during last three years ending 31.03.12.
- b) Should have satisfactorily completed at least one or more work of multistoried building of similar nature for design, manufacture, supply, installation, testing and commissioning of machine room less lifts for reputed corporate, institutes other than residential buildings costing not less than Rs. 50.0 Lacs (in a single contract) during the last 3 years ending 30.06.2012.
- c) Should have a valid financial solvency of **2** Crore Rupees from a scheduled bank.
- d) Have not incurred any loss during the last 5 financial years ending 31.03.12.
- e) The Contractor shall have a valid registration certificate for Sales Tax, Service Tax and Works Contract Tax.

Certificate of proof from the appropriate authority for all the above points are required to be submitted by the Contractor. All the submittals shall have to be stamped and signed by authorized signatory of the Contractor.

- 3. Should have sufficient manpower at Site (technical & non-technical), equipment, T & P, scaffolding etc. to execute and complete the work within specified time schedule.
- Contractor shall have sufficient technical key personnel to provide best quality workmanship strictly adhering to approved programme for completion of work.
- 5. Contractor to submit the Site Organization chart, scheme for completion of the work, list of equipments, T & P, scaffolding etc. as proposed at Site for execution of work.
