The establishment of India's first women gram sabha on June 18, 2012, marked a historic step in the fight for the girl child, earning Jaglan accolades and national recognition.

A significant aspect of Jaglan's work lies in his commitment to reinvesting award money into women-centric initiatives, reaching an impressive 30%. Notably, his efforts garnered

attention from the then-President of India, Pranab Mukherjee, who contributed 50 lakhs for the welfare of Jaglan's village. Beyond his immediate community, Jaglan adopted 142 villages through his NGO, extending his commitment to social development.

In addressing women's health, Jaglan's initiatives included distributing sanitary pads, medicines, and essential support, alongside promoting awareness through a period chart. The impact of his work was captured in the national award-winning documentary "Son Rise," showcasing the transformative power of Jaglan's "Selfie with Daughter" campaign.

Moreover, Jaglan's emphasis on maintaining civility within communities, manifested through fines for using slangs, reflects his dedication to creating an environment of respect and dignity. With over 100 campaigns, 75 of which were women-centric, Sunil Jaglan stands as a beacon of change, illustrating the profound impact that one individual can have on a community and beyond.
