- d. Antivirus software should support all flavors of Windows Operating Systems like WINDOWS SERVER 2012, 2016, 2022, WINDOWS 10, WINDOWS 11 and above, Mac OS and Linux etc. covering both Desktops and Server Class Machines.
- e. The vendor shall have skilled and experienced professional engineer for implementation & consultation. Adequate training should be provided to the personnel who are involved in the installation, implementation and support.
